# United States v. Richard M. Scrushy 2:05-CR-119-MEF **EXHIBIT V-H**

# Declaration of Nick Bailey Under Penalty of Perjury Pursuant to 28 U.S.C. § 1746

- I, Nick Bailey, declare and state as follows:
  - 1. I am over eighteen years of age and of sound mind.
  - 2. I make this Declaration of my own free will, and I have neither been threatened nor offered any inducement to make the statements below. I have consulted with counsel of my own choosing and reviewed this declaration with my counsel prior to signing it.
  - 3. I have personal knowledge of the facts set forth below.
  - 4. As I estimated in my testimony at the trial, I attended two or three dozen interviews during the Siegelman/Scrushy investigation where I met with government prosecutors and investigators in the same meeting. In addition, there were many, many occasions on which I met with or was contacted on the telephone by FBI or other government agents working on the case. At least one representative of the federal government was present at all of the interviews I attended. These meetings typically lasted 2 to 3 hours, and some of them extended from one day to the next. Altogether, I would estimate that I spoke with government prosecutors or agents approximately 60 to 70 times although a number of those meetings and conversations did not involve Governor Siegelman or Mr. Scrushy.
  - 5. Based on my recollection and review of documents, including the FBI "302s" that were provided to me and my attorney and represented to be a copy of the materials provided to the defense team, I believe that there were at least 24 occasions when I met with government representatives Assistant U.S. Attorneys, employees of the Alabama Attorney General's Office, and/or federal law enforcement officials to discuss issues related to Governor Siegelman and/or Mr. Scrushy (excluding meetings that primarily

- concerned other targets or potential targets of the government's investigation) that are not included in the material furnished to me by the government as being my 302 statements and Grand Jury testimony. I will describe these meetings in more detail below.
- 6. I recall that one or more of the government representatives took notes at each and every one of these meetings. When Assistant U.S. Attorney Julia Weller was present, she typed constantly on her laptop. My opinion is that Ms. Weller took verbatim notes because she was the "eyes and ears" of Leura Canary at these meetings. After Assistant U.S. Attorney Steven Feaga was assigned to the case, he was generally accompanied to the interviews by J.B. Perrine, another AUSA, who took notes. Other government representatives generally took notes, on laptops or written by hand, at all of these meetings. When only agents were present (and such meetings would almost always include Keith Baker and Bill Long), one or both of them took notes, and Keith Baker was usually the one who did so.
- 7. The government later provided me with a 3-ring binder containing my 302 statements and Grand Jury testimony, to prepare for the trial. I inserted the notes that I had been making in this binder, and made additional notes in it as well. I recently found the binder, and I have provided what is, to the best of my knowledge, a true and complete copy of the binder and the notes it contained to my attorney.
- 8. Soon after Mr. Feaga was assigned to the case (which I recall as being in the spring or summer of 2004), he told me that the government was "starting over," top to bottom, with the investigation. At an interview at Maxwell AFB attended by Mr. Feaga and by Richard Pilger from the Public Integrity Section of the Department of Justice, they told me that "Washington" had ordered them to start over with the investigation. After Mr.

Feaga came on board, he did start all over, and in his first interviews with me he spent a lot of time getting just the general "lay of the land" about the Governor's office, how things worked inside the administration, etc.

9. I have identified 24 meetings (and there may be more) that touched on subjects relevant to the Siegelman and/or Siegelman/Scrushy prosecution. I know that the five 302s that we were given to us summarize only a fraction of the meetings that I had with government representatives. Below is a list of those meetings that is true and accurate to the best of my knowledge and recollection. I have also included, to the best of my ability, the names of the persons present and the subjects discussed. I am also attaching a "List of Persons Attending Government Meetings" that identifies the affiliations, to the best of my understanding, of the people who were at some of the meetings with the government that I attended.
